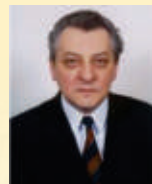

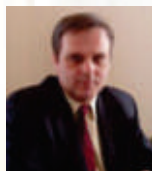

## *Danylo Halytsky Lviv National Medical University*

**229 years old Danylo Halytsky Lviv National Medical University (LNMU)** is one of the oldest and biggest medical educational institutions in Ukraine. It is one of the leading medical universities of the IV level of accreditation. LNMU begins from the Medical Faculty of Lviv University, which was opened on November 16, 1784, according to the privilege of the Austrian emperor Josef II.

22 scientific schools actively function and develop in University: obstetrics and gynecology, biochemical, hygienic, infectious diseases, history of medicine and pharmacy, microbiological, morphological, neurology and neurosurgery, oncology, otorhinolaryngology, ophthalmological, pathological anatomy and pathological physiology, pediatric, psychiatric, dentistry, internal diseases, pharmacological, physiological, phthisiatry, chemistry and pharmacy, surgery.

Lviv National Medical University provides admission for foreign citizens to the undergraduate education at Faculty of General Medicine, Faculty of Dentistry and Faculty of Pharmacy, also provides admission for Preparatory Course and Postgraduate Training. The amount of foreign citizens for Undergraduate Education – 250 students, Preparatory Course – 100 students, Postgraduate training – 150 students.

At 78 University departments, there are 1211 scientists: 134 Doctor of Sciences and more than 620 PhD degree holders, including 113 full professors, 369 associate professors, 50 senior tutors, 662 assistant professors, 17 researchers. Among them there are 23 Members, 7 Corresponding Members of Academy of Sciences, 12 Honored Workers of Science and Technology, 7 Honored Workers of Education, 19 Honored Doctors, 1 Honored Worker of Physical Culture and Sport, 8 Laureates of the State Prize of Ukraine in Science and Technology.

Training of specialists in Lviv National Medical University is provided at 6 Faculties: Medical Faculty, Faculty of Dentistry, Faculty of Pharmacy (regular and correspondence education), Faculty of Postgraduate training, Faculty of Foreign Students..



Beginning from 1961 University provides education for foreign citizens. During 50 years over 2,5 thousand doctors and pharmacists - foreigners have got education here and have been working successfully as doctors and pharmacists in many countries of the world. Since 1997 education is provided in English and is rapidly developing. Now 70% of University foreign students study in English Medium Program.



University library contains more than 530000 volumes of textbooks, manuals and other relevant medical literature. Library has modern computer equipment. She has Internet connection and is connected with other scientific city libraries.

University in the Member of International and European Associations of Universities, and also is the member of almost 70 another international organizations, academies,

federations. University is included into Directory of World Health Organization (WHO) and into Directory of Universities of Central European countries. In terms of University activities LNMU has the leading positions in ratings of higher educational institutions and higher medical educational institutions of Ukraine (Scopus 2010 – the 2nd place among medical universities and academies of Ukraine).

Clinical departments of University have the fund of more than 10000 beds (41 affiliated hospitals), 9 polyclinic departments with 3510 attendances during shift, University dental medical centre for more than 2000 attendances during shift.

Today Danylo Halytsky Lviv National Medical University combines 6 faculties, medical college, 78 departments (including 48 clinical departments), 14 academic buildings, 41 affiliated hospitals, University dental medical centre for more than 2000 attendances during shift, teaching drugstore, botanical garden, CRL and Laboratory of industrial toxicology, Institute of clinical pathology, research centre for investigation of anticancer drugs, scientific library, 8 student hostels, sanatorium, student cafes and canteens, sports and health recovery camp “Medyk”.



## Learning Curriculum & ECTS

The curriculum for undergraduated doctors', dentists, pharماسicts preparation at medical, dentistry and pharmaceutical faculty in specialty "General medicine", "Dentistry" and "Pharmacy" respectively is based on European Credit Transfer System (ECTS), which is oriented towards the ability of students' study achievements recognition, irrespective of the place of study. The normative term learning curriculum realization is expected after 6 years of study (360 credits ECTS). After finishing it successfully student receives the diploma of doctor, dentist or magister of pharmacy



All the lectures, seminars, practical classes are taught in three languages: Ukrainian, Russian, English.

The structure of learning curriculum is integrated and is orientated towards following the logical succession of subject teaching.

The curriculum includes two stages of undergraduated doctors' preparation: preclinical and clinical. Three primary years of study are devoted to majoring in the main subjects. First of all these are: human anatomy, histology, cytology and embryology, medical chemistry, physiology, biophysics. These subjects are the main theoretical part of clinical medicine that doctor expert deals with. Clinical subjects are taught beginning with the 3rd till the 6th year of study. State certification of students-graduates consists of standardized test – state exam – and practically orientated state exam. ECTS credits are a value allocated to course units to describe the student workload required to complete them.

In ECTS: the study plan is arranged into 6 years of study or 360 credits ECTS. One academic year lasts 40 weeks and includes 60 credits (1 week – 1,5 credit ECTS), 1 credit ECTS includes 30 academic hours. An academic year contains 1800 academic hours. The total amount of academic hours includes: the time for providing lectures, practical work, seminars, tutorials, consultations, practices, self-reliant and individual work and controlling steps. The schedule of study process from 1st till 6th year or till 5th year in dentistry or pharmaceutical faculty consists of two academic semesters. In the schedule is expected the additional time for completing the study of separate modules (their re-passing, increase of the rating, etc.) – 2 weeks after completion the spring semester on 1-5 years.

Standardized test – state exam – consists of two exams "Step 1" and "Step 2". Exam "Step 1" is integrated and takes place after the third year. "Step 2" is a component of state board examinations.

Students of General Medicine faculty have to pass practically orientated state exam in 5 subjects: "Internal, Professional and Infectious diseases", "Surgical Diseases with Pediatric Surgery", "Obstetrics and Gynecology", "Pediatric Diseases with Pediatric Infectious Diseases",



"Hygiene, Social Medicine, Economics and Organization of Public Health Care". The aim of practically orientated state exam is to value the quality of solving the typical problems by graduates and demonstrating the corresponding skills and habits in conditions that are approximate to realistic. The exam takes place directly "at the bed of a sick man" and in specially equipped classes. It evaluates the skills of every graduate to prepare complaints and case history, to make the examination of sick, to make the plan after examining, to estimate the results of laboratory and instrumental research.

# Admission

## 1. Admission & education conditions for foreign citizens.

- ✓ Academic Year starts September 1
- ✓ Preparatory course starts October 1

## 2. Admission documents required

- ✓ Giving out the Invitation to study for foreign citizens is carried out by Ministry of Education and Science of Ukraine and also by the University under the following circumstances: foreigners should present all the required documents (or copies) to the University under Visa support done by Ministry of Education and Science of Ukraine.
- ✓ The educational program of all faculties of Danylo Halytsky Lviv National Medical University is conducted in Ukrainian, English and Russian languages (according to the choice).
- ✓ 15.08-15.11- is the term of admission foreign citizens to study.



## Foreign citizens should present the following documents:

- Application to the name of the Rector of the University with request for enrollment for studies at the University on the commercial basis;
  - Completed application form (including full name, date of birth, passport number, citizenship, permanent address, phone, fax and e-mail of applicant);
  - Original of Transcript of high school or college/university education with complete listing of courses, together with Originals of all diplomas, certifications and licenses (should be translated into Ukrainian language and legalized by the Notary public and by the Ukrainian Embassy in your country);
  - Original of Birth Certificate (should be translated into Ukrainian language and legalized by the Notary public and by the Ukrainian Embassy in your country);
  - Copy of inner page(s) of Passport
  - Results of physical examination (should be translated into Ukrainian language and legalized by the Notary public and by the Ukrainian Embassy in your country);
  - Results of laboratory test for the presence of the AIDS virus (should be translated into Ukrainian language and legalized by the Notary public and by the Ukrainian Embassy in your country);
  - 12 photographs measuring 3x4 cm each with white background.
- ✓ The Tuition Fees for foreign citizens in Ukraine are determined by fixed order of the Ministry of Education and Science, the Ministry of Finance and the Ministry of Economics of Ukraine
  - ✓ Foreign citizens can be enrolled to the University after their Chemistry and Ukrainian, English or Russian Entrance Interview results.
  - ✓ Foreign citizens, who are given with state grants according to the international agreements, general state programs, other international obligations Of Ukraine, can be enrolled to the University on the basis of the documents from the Ministry of Education and Science of Ukraine within the limits of state order.
  - ✓ Foreign citizens can be enrolled to the University after signing the Contract for study with the University and having paid Tuition and Hostel Fees.
