With reference to your email, please find the requested information below:

1. Question - What is the duration of a Medical Doctor Degree or MBBS in Germany for local students?

A regularly structured degree course in medicine takes six years and is completed by a state exam (Staatsexamen), with which one obtains a license to practice as a physician (approbation).

2. Question - What is the duration of a Medical Doctor Degree or MBBS in Germany for foreign students?

Same as above.

3. Question - What is the Language of instruction for a Medical Doctor Degree or MBBS in Germany (English or other language)?

Medical education in Germany takes place solely with German as the medium of instruction.

4. Question - What is the provision & Duration of Internship?

After passing Part 2 of the German Medical Licensing Examination, the students complete a practical year ata clinic. They work in surgery, internal medicine and on a ward of their choice.

- 5. Question Can an Indian student obtain a license to practice in Germany and is this at par with the Registration granted to local citizens in Germany? Yes
- 6. Question What is the complete Process of Registration in Germany?

- 2. Requisite information is placed below ad seriatim:
- (i) Does Germany allows foreign medical students to be registered in Germany at par with local citizens.

Yes, Germany allows foreign students to be registered for medical courses at par with local citizens.

However, there are a few requirements for the admission:

- Excellent grade in Higher Secondary School certificate (Abitur).
- Must have German Language efficiency of C1 level.
- Some universities also require the "Medizinertest" (officially known as the Test für Medizinische Studiengänge (TMS) [Test for Degree Courses in Medicine] (only in German) to get admission in the course.

A regularly structured degree course in medicine takes six years and three months and is completed by a state exam (*Staatsexamen*), with which one obtains a license to practice as a physician (*approbation*).

(ii) Does Germany offers its Medical Education Teaching in English Medium.

Medical courses are only available in the German language.
