Dear Sir

The National Medical Commission has issued a Gazette Notification on the 18th of Nov. 2021 – the Foreign Medical Graduate Licentiate Regulations, 2021 (copy attached).

Because of the above lot of questions have come up about Foreign Medical Education & we are not able to decide about the future of our kids in the absence of facts about Medical Education Abroad.

We have only one source to get answers to various questions on Medical Education in India and that is **National Medical Commission**, the regulator of medical education in India.

Since the information required by me is about **Foreign Medical Education** in a country abroad and for that only authentic source to get proper information of the questions is only & only the Indian Embassy in that country

Sir, every year a large number of Indian students join Medical Education in **Moldova** and it is really difficult for a student or his or her parents to know about the facts of Medical Education on foreign soil before actually joining the institution in that country; it is really difficult for both the student and his or her parents.

You as the representative of our country on that foreign soil are our trust and guardian of Indian citizens there; you can become a guiding force for these students with every possible proper authentic information and save them from getting trapped by false information from the Medical Education Consultants here in India.

Sir, look forward to answering the following seven questions from your good self.

- 1. Question What is the duration of a Medical Doctor Degree or MBBS in Moldova for local students?
- 2. Question What is the duration of a Medical Doctor Degree or MBBS in Moldova for foreign students?
- 3. Question What is the Language of instruction for a Medical Doctor Degree or MBBS in Moldova (English or other language)?
- 4. Question What is the provision & Duration of Internship?
- **5.** One of the major points of the FMGL Regulations 2021, is that Indian students need to be: "4 (b) registered with the respective professional regulatory body or otherwise, competent to grant license to practice medicine in their respective jurisdiction of the country in which the medical degree is awarded and at par with the license to practice medicine given to citizen of that country".

This means that an Indian Student who studies medicine in **Moldova** and then wishes to register in India; first needs to Register with the **Moldova** Medical Licensing Regulatory Body & that Registration must be at Par with the Registration given to a citizen of **Moldova**.

Question 5 - Can an Indian student obtain a license to practice in Moldova and is this at par with the Registration granted to local citizens in Moldova?

- 6. Question What is the complete Process of Registration in Moldova?
- 7. Question Do they have any licensing exam in Moldova and if Yes, in which language?



Dear Mr. Ambassador,

Nicolae Testemitanu State University of Medicine and Pharmacy of the Republic of Moldova presents sincere compliments to you.

During the last years, there was established a good collaboration between the Embassy of India to Albania, Moldova and Romania and our University. *Nicolae Testemitanu* University is institutionally internationally accredited by the Independent Agency for Accreditation and Rating (no. 46 of 14.06.2019) based on the standards of the World Federation of Medical Education for a period of 5 years and nationally for a period of 5 years by Order of the Ministry of Education, Culture and Research no.1058 of 28.08.2019. The "Medicine" study program is accredited by the National Agency for Quality Assurance in Education and Research (Order of the Ministry of Education, Culture and Research no. 1902 of 26.12.2018) for a period of 5 years.

Currently, about 850 citizens of India study at our University. In accordance with the new requirements of the NMC concerning the duration of medical education, internship after graduation and the rights of the graduates to practice in the country where they studied medicine, let us inform you the following:

- Indian students study medicine according to the same syllabus as other students, both local and international. Level of qualification – Integrated Higher Education (Bachelor and Master's Degree), ISCED level 7 / 7NQFRM / 2QF-EHEA / level 7EQF.
- 2. The duration of studies at the integrated undergraduate program in Medicine, English medium, is 6 years (360 credits) and includes theoretical courses, practical classes and seminars, current and summer clinical internships. The study period exceeds the minimum 54 months recommended by the NMC.
- 3. The University guarantees organization in the University clinics of minimum 12 months postgraduate clinical internship according to the recommendations of the NMC.
- 4. According to the p.5.1 and p.5.2 of the Diploma Supplement, the graduates of the integrated undergraduate program in Medicine have access to

postgraduate specialized education – residency and higher doctoral studies, ISCED level 8 / 8NQFRM / 3QF-EHEA /level 8EQF, and have the right to take examination during the residency, higher doctoral studies and are eligible to be employed on the labor market according to the occupational framework.

5. According to p. 49 of all the Regulation on the organization of residency studies, approved by the Decision of the Government of the Republic of Moldova no. 367 of June 10, 2020, within the residency clinics/institutions, the resident is employed as resident doctor/pharmacist, according to the specialty, and provides medical and pharmaceutical assistance in accordance with his level of professional training, within the volume and limits established in the employment contract and its annexes

In this context, *Nicolae Testemițanu* State University of Medicine and Pharmacy of the Republic of Moldova meets the new requirements submitted by the NMC to higher medical education institutions abroad.
