Respected Sir,

I am writing to you about my previous emails and RTI applications sent to the Embassy of India, Bishkek, which have not received any response yet. I wanted to get information about medical education in Kyrgyzstan for Indian students from our embassy, as they are responsible for providing such guidance.

I believe that we cannot solely rely on foreign universities or institutions for accurate information about medical education, especially when the students' future is at stake. It is crucial to receive an official advisory from our embassy.

I had asked the Embassy of India, Bishkek the following seven questions, which could serve as an advisory for Indian students planning to study medicine in Kyrgyzstan:

- **1.** What is the duration of a Medical Doctor Degree or MBBS in Kyrgyzstan for local students?
- **2.** What is the duration of a Medical Doctor Degree or MBBS in Kyrgyzstan for foreign students?
- 3. What is the language of instruction for a Medical Doctor Degree or MBBS in Kyrgyzstan (English or another language)?
- 4. What are the provisions and duration of internships?
- 5. Can an Indian student obtain a license to practice in Kyrgyzstan, and is it equivalent to the registration granted to local citizens?
- 6. What is the complete process of registration granted to local citizens in Kyrgyzstan to practice as a medical doctor?
- 7. Are there any licensing exams in Kyrgyzstan, and if yes, in which language?



Each country has rules and regulations regarding medical education and licensing for medical practice for their local students. I believe that the Embassy of India, Bishkek can access this information officially, while I, as a common person, cannot.

Students are going to Kyrgyzstan in bulk even after FMGL 2021 in the Absence of clarity on the rules and regulations of medical education there and the students can face problems here in India after the completion of course.

Let us educate the students before joining Medical Doctor Course Abroad; so I kindly request your assistance in obtaining answers to these questions from the Embassy of India, Bishkek. It would be helpful if the information could be posted as an advisory on the official website of the Embassy.

Medical Education Consultants in India are attracting the students with their interpretation of various clauses of this NMC - FMGL 2021 that suits their business.

This is going to be a disaster if things are not clarified now.

The National Medical Commission has issued a Gazette Notification on the 18th of Nov. 2021 – the Foreign Medical Graduate Licentiate Regulations, 2021 (copy attached).

Because of the above lot of questions have come up about Foreign Medical Education & we are not able to decide about the future of our kids in the absence of facts about Medical Education Abroad.

We have only one source to get answers to various questions on Medical Education in India and that is **National Medical Commission**, the regulator of medical education in India.

Since the information required by me is about **Foreign Medical Education** in a country abroad and for that only authentic source to get proper information of the questions is only & only the Indian Embassy in that country

Sir, every year a large number of Indian students join Medical Education in **Kyrgyzstan** and it is really difficult for a student or his or her parents to know about the facts of Medical Education on foreign soil before actually joining the institution in that country; it is really difficult for both the student and his or her parents.

You as the representative of our country on that foreign soil are our trust and guardian of Indian citizens there; you can become a guiding force for these students with every possible proper authentic information and save them from getting trapped by false information from the Medical Education Consultants here in India.

One of the major points of the FMGL Regulations 2021, is that Indian students need to be: "4 (b) registered with the respective professional regulatory body or otherwise, competent to grant license to practice medicine in their respective jurisdiction of the country in which the medical degree is awarded and at par with the license to practice medicine given to citizen of that country".

This means that an Indian Student who studies medicine in **Kyrgyzstan** and then wishes to register in India; first needs to Register with the **Kyrgyzstan** Medical Licensing Regulatory Body & that Registration must be at Par with the Registration given to a citizen of **Kyrgyzstan**.

Can an Indian student obtain a license to practice in Kyrgyzstan and is this at par with the Registration granted to local citizens in Kyrgyzstan?

- 6. What is the complete Process of Registration in Kyrgyzstan?
- 7. Do they have any licensing exam in Kyrgyzstan and if Yes, in which language?

Respected Sir,

Question may arise why a Grievance was raised by me through PMO?

As is mentioned in my previous letter number: PMOPG/D/2023/0093572 dated 02.05.2023 (copy attached); earlier I had sent a number of emails and RTI applications addressed directly to the Embassy of India, Bishkek dated Sep 1, 2022; Sep 14, 2022 & 05 October 2022 followed by RTI applications No. MEABS/R/E/22/00008 dated 01.06.2022; No. MEABS/A/E/22/00005 dated 07/06/2022 but never got a proper reply from the Embassy of India, Bishkek so finally decided to send a letter through PMO vide Grievance registration number: PMOPG/D/2023/0093572 however one RTI the Embassy of India in Bishkek replied that reads - *The applicant is advised to seek the relevant information from the concerned Universities/ Colleges in Kyrgyzstan directly*.

Similar reply is received for PMO Grievance registration number: PMOPG/D/2023/0093572 from Shri Devesh Uttam, Joint Secretary, CPV Division Ministry of External Affairs for PMOPG/D/2023/0093572 that reads:-

We have raised the issue with concerned authority. In reply, it is stated that the information is not available with this Embassy. The applicant is being informed that as per the extant instructions, the Embassy is not required to gather information from various sources and create information and provide it to applicant. The applicant is further advised to seek the relevant information from the Universities Colleges in Kyrgyzstan directly.

I believe that the reply from the Embassy of India, Bishkek advising to seek the relevant information from the Universities Colleges in Kyrgyzstan directly is not going to be a good decision and in favour of Indian students and India.

Respected Sir, we cannot rely on foreign universities or institutions for accurate information about medical education, especially when the students' future is at stake. It is important to receive an official advisory from our embassy instead.

I believe the Embassy of a country is definitely required to gather such information from various sources and create information and provide it to any Indian Citizen as the Embassy is supposed to take care of all interests concerning India and Indian citizen like various other embassies of India have issued similar details in the shape of advisory on embassy websites to educate the aspiring Indian Students planning to study in a country where only Indian embassy can be source of authentic information; thereby saving the Indian students from being misled through wrong information given by the individuals or institutions for their financial gains.

Respected Sir, the National Medical Commission issued a Gazette Notification; the Foreign Medical Graduate Licentiate Regulations, 2021 (FMGL 2021) on the 18th of Nov. 2021 that is going to affect the students studying medicine abroad and their future thereby our country.

We need to tell the students if the medical education in a particular country is satisfying the norms formulated by the National Medical Commission or not; else it will be a disaster.

Respected Sir, since September 2022, I have been requesting the Embassy of India, Bishkek for the answer to following seven questions, which will serve as an advisory for Aspiring Indian students planning to study medicine in Kyrgyzstan; and answer to these questions like many our Indian Missions abroad did, can be put on the embassy website for the information of aspiring students:

- **1.** What is the duration of a Medical Doctor Degree or MBBS in Kyrgyzstan for local students?
- **2.** What is the duration of a Medical Doctor Degree or MBBS in Kyrgyzstan for foreign students?

- **7.** Are there any licensing exams in Kyrgyzstan, and if yes, in which language?

Respected Sir, students are seeking admission abroad in various countries without knowing the facts, as the same are not available and after completion of the degree when a student will approach the National Medical Commission for licensing in India, he or she may face rejection of that degree. In that case an Indian student, now a doctor, will lose 5 to 7 crucial years of his/her career and their parents hard earned money.

The students are going to be big Losers (losing the precious time of their career) and their parent's money (huge funds) but above all the **Huge Forex of our country**.

Looking at the Gazette Notification and other rules & regulations governing medical education in India and Abroad if the Indian Embassy does not educate the aspiring doctors today and the National Medical Commission rejects the degree or degrees of the students on return, like first batch under FMGL2021 is expected to return in 2027 calculating at 15000 students / year there will be an expected loss of approximately 1,890,000,000 USD of FOREX to the India between 2021 to 2027.

Foreign universities or institutions are working to take the maximum number of students for maximum earning and they do not worry about what will happen to the students on return to India for licensing in India.

Every country has its rules and regulations governing medical education and licensing for medical practice for their local students. Only the Embassy of India can have access to this information officially, while I, as a common person, cannot.

Students are going in bulk to Kyrgyzstan even after FMGL 2021 in the Absence of clarity on the rules and regulations of medical education there and the students can face problems here in India after the completion of course.

Let us take this responsibility for the country and educate the students through an advisory before joining a medical doctor degree course abroad; I kindly request your assistance in obtaining answers to these questions from the Embassy of India in Bishkek.

It would be great help for all aspiring students if the information could be posted as an advisory on the official website of the Embassy.
